



Limited Warranty

Urban Partners, (.Warrantor.) warrants to the original residential purchaser of this Urban Rebounder (.Product.) that, should it prove defective by reason of improper workmanship and/or material: For One year from the date of the original purchase, Warrantor will replace any defective frame, hinges or hardware without charge plus S/H. For one year from the date of original purchase, Warrantor will replace any defective mat, without charge plus S/H. Parts used for replacement are warranted for the remainder of the original warranty period. Warrantor will provide parts of the product for a warranty repair without charge when consumer contacts the warrantor. Shipping expenses are the purchaser's responsibility.

1. TO OBTAIN WARRANTY SERVICE, consumer must contact an Urban Partners service center and obtain a Return Authorization Number. Shipping expenses are the purchaser's responsibility. Proof of purchase is required when requesting warranty service. Purchaser must present the sales receipt or other document which establishes proof of purchase. Subject to the conditions and limitations set forth above, Urban Partners will, at its option, either repair or replace, the defective part or product. Urban Partners may request any defective part(s) be returned at consumers shipping cost to the service center for inspection prior to a replacement part(s) being sent.
2. **THIS WARRANTY DOES NOT COVER** defects caused by: modification, alteration, physical abuse to, or misuse of, the product or operation thereof in a manner contrary to the accompanying instructions; use of product by any user weighing in excess of three hundred (300) pounds; or caused by shipment of the product to an Urban Partners service center for service. This warranty also excludes all products purchased or serviced outside the United States of America.
